NOTIFICATION

EXEMPTION FROM RQUIREMENTS ON THEORETICAL EXAMINATIONS AND APPLICANTS FOR LICENCES AND RATINGS

The Civil Aviation Authority of the Czech Republic grants an exemption (the Exemption) from Part-FCL.025, FCL.060, FCL140A, FCL 140.H, FCL.725, FCL.735.A, FCL.735.H, FCL.805,, FCL.825, FCL.830 and point (1) of Section H of Appendix 3 to Annex I (Part-FCL) requirements of the EU 1178/2011 regulation (Aircrew Regulation) according to the article 71 (1) of the EU 2018/1139 regulation (Basic Regulation) valid for persons who are applying or who will apply the Civil Aviation Authority of the Czech Republic (CAA CZ) for an aeroplane or helicopter pilot licence issue.

1. Applicable Persons:

- (1) The persons who are attending or will attend theoretical examinations at CAA CZ (the Attendants)
- (2) The persons who are applying or will apply CAA CZ for licence or rating issue (the Applicants)
- (3) The persons who are attending or have attended the MCC(A), MCC(H), ATP(H) modular theory, NIGHT(A), NIGHT(H) and EIR courses in ATOs certified by CAA CZ (the Students)

2. Validity Period of the Exemption:

- (1) When the validity period of any of the following documents ends within the period of 01.03.2020 till 31.07.2020:
 - (a) Recommendation by a training organisation for taking theoretical knowledge examinations
 - (b) Certificate on theoretical knowledge examinations for the purpose of licence / IR / EIR rating issue

its validity period is extended until 31.07.2020.

(2) When any of the CPL(A)/(H), IR(A)/(H), EIR, ATPL(A)/(H) and ATPL/IR(H) commenced theoretical examination was inaccessible since 16.03.2020 the max time period for the examination is extended by the time period that equals the time period during which the applicant was unable to access the examination. Note: The recovery date of the theoretical examinations is still unknown. Once known it will be published at www.caa.cz – News.

- (3) When the time period in any of the following cases ends within the period of 01.03.2020 till 31.07.2020:
 - (a) The time period between the commencement of a class / type rating training course and the pass of the skill test
 - (b) The time period between the pass of the skill test and the application for the issue of the class / type rating
 - (c) The time period between the commencement and end of an IR(A)/(H) or EIR skill test.

its validity period is extended until 31.07.2020:

(4) When the time period between the commencement and the end of the MCC (A)/(H), ATP(H) modular theory, NIGHT(A)/(H) or EIR training course exceeds the maximum original time period of the course its validity period is extended until 31.07.2020.

3. Conditions of the Exemption:

The Exemption is granted when any person is not able to meet requirements in the above mentioned cases in a usual way due to measures having been applied to fight spread of the COVID-19 virus, i.e. particularly limitation of movement of persons, access to CAA CZ, operations of training organisations and examiners and when the following requirements have been met:

- (1) Recommendation by a training organisation for taking theoretical knowledge examinations (original validity period of 12 months): The Exemption will be granted by CAA CZ automatically as soon as the Attendant logs in for another attempt.
- (2) Certificate on theoretical knowledge examinations for the purpose of licence / IR / EIR rating issue (original validity period of 24 months for PPL and of 36 months for the others). The Exemption will be granted by CAA CZ automatically as soon as the Applicant applies for relevant licence / IR / EIR rating.
- (3) CPL(A)/(H), IR(A)/(H), EIR, ATPL(A)/(H) and ATPL/IR(H) commenced theoretical examination was inaccessible since 16.03.2020 the max time period for the examination (originally 18 months) is extended by the time period that equals the time period during which the applicant was unable to access the examination. The Exemption will be granted by CAA CZ automatically as soon as the Attendant logs for another attempt.
- (4) The time period between the commencement of a class / type rating training course and the pass of the skill test (original max period of 6 months). **The Exemption will be granted by CAA CZ automatically** as soon as the Applicant applies for relevant rating.

- (5) The time period between the pass of the skill test and the application for the issue of the class / type rating (original max period of 6 months). **The Exemption will be granted by CAA CZ automatically** as soon as the Applicant applies for relevant rating.
- (6) The time period between the commencement and end of an IR(A)/(H) / EIR skill test (original max period of 6 months). **The Exemption will be granted by CAA CZ automatically** as soon as the Applicant applies for relevant rating.
- (7) When the time period between the commencement and the end of the MCC (A)/(H) (originally max 6 months), ATP(H) modular theory (originally max 18 months), NIGHT(A)/(H) (originally 6 months) and EIR (originally 36 months) training course exceeds the above maximum original time period of the course CAA CZ will grant an exemption based on application of the training organisation. After consultation with the training organisation CAA CZ can deem necessary that the Student has received additional training.

4. Procedure for Grant of the Exemption:

- (1) Recommendation by a training organisation for taking theoretical knowledge examinations: Not applicable for the Student nor for the organisation. As soon as the Student commences the examinations CAA CZ notes grant of the Exemption on the delivered Certificate by words: COVID-19 exemption.
- (2) Certificate on theoretical knowledge examinations for the purpose of licence / IR / EIR rating issue: **Not applicable for the Student nor for the organisation.** CAA CZ notes grant of the Exemption on the delivered Certificate by words: *COVID-19 exemption*.
- (3) CPL(A)/(H), IR(A)/(H), EIR, ATPL(A)/(H) and ATPL/IR(H) commenced theoretical examination that was inaccessible since 16.03.2020: **The Applicant logs in for the next attempt when ready and a slot is available**.
- (4) The time period between the commencement of a class / type rating training course and the pass of the skill test: **Not applicable for the Student nor for the organisation.** CAA CZ notes grant of the Exemption on the delivered Application and Report Form by words: *COVID-19 exemption*.
- (5) The time period between the pass of the skill test and the application for the issue of the class / type rating: **Not applicable for the Applicant.** CAA CZ notes grant of the Exemption on the delivered Application and Report Form by words: *COVID-19 exemption*.
- (6) The time period between the commencement and end of an IR(A)/(H) / EIR skill test: **Not applicable for the Applicant.** CAA CZ notes grant of the Exemption on the delivered Application and Report Form by words: *COVID-19 exemption*.
- (7) The time period between the commencement and the end of the MCC (A)/(H), ATP(H) modular theory, NIGHT(A)/(H) and EIR training course: **Procedure for the training organisation:** Relevant training organisation sends a filled in
