revalidation	Fulfil 2 of 3 requirements: (1) 36 months preceding the expiry date of certificate: 50 hours of flight instruction in aeroplane as FIs, TRIs, CRIs, IRIs, MIs or examiners. If the privileges to instruct for the IR are to be revalidated 10 of those hours shall be flight instruction or examination for IR and shall have been completed in the period of 12 months immediately preceding the expiry date of the FI certificate. (2) 36 months preceding the expiry date of certificate complete refresher seminar (3) 12 months preceding the expiry date of FI or IRI certificate pass an assessment of competence. This requirement is obligatory for each alternate revalidation.
renewal	12 months before the application for the renewal: (1) Complete instructor refresher training FI or IRI as relevant. (2) Pass the assessment of competence.
	CRI requirements
	36 months preceding the expiry date of certificate fulfil 2 of 3 requirements: (1) Conduct at least 10 hours of flight instruction or examination as a CRI. If both CRI-SE and CRI-ME are held, hours shall be equally divided between SE and ME aeroplanes. (2) Complete a refresher training as a CRI. (3) Pass the assessment of competence on SE or ME aeroplane as relevant. This requirement is obligatory for each alternate revalidation.
